There are 3 bills lowering the compulsory attendance age. They will be heard and testimony will be taken at the House Elementary and Secondary Education Committee meeting on Tuesday morning. <u>HB 2125</u>, sponsored by Rep. Ian Mackey, changes the compulsory attendance age from 7 years old to 5 years old.

HB 2177, sponsored by Rep. Bruce Sassmann, changes the compulsory attendance age from 7 years old to 6 years old.

HB 2323, sponsored by Rep. Jeff Farnan, changes the compulsory attendance age from 7 years old to 6 years old
