**EXECUTIVE DIRECTOR REPORT**

**Mid-Year Evaluations**

How is your school year going? What are some things that are going great? What is something that needs to be changed or improved? Changes that need to be made now or something that you need to look at changing for next year? With the curriculum catalogs starting to arrive in the mail, it is so easy to start dreaming about next year, but first let's look at the current year.

Are you where you want to be in regard to curriculum plans and hours? Or has this year been full of unexpected events that have put school on the back burner to deal with the urgent? If it has been a rough year, let's take a look at some of the things that can help make the second half of the year better and easier, especially if things are still in survival/recovery mode. First, write down exactly where things are from what lesson number/unit each child is in of each subject, figure out where you are at with the required hours. Write down one success that each child has had – it doesn't have to be school related, just a success. Sometimes the greatest achievements have nothing to do with academics! Now let's figure out what needs to be accomplished to finish out the year. There is nothing that says that a curriculum has to be completed. It could be that you decide to put the curriculum away and work on other (cont. on page 2)



Then, in a couple of months, decide if you want to finish it next year or start something new. Or it could be the child knows the material being covered and you need to decide if you go to the next level or just decide to do something totally different for the rest of the year.

So how to get hours in when either there are a lot of hours to complete or a curriculum break is needed, but hours are still needed. One of the easiest ways is reading – you read to the child, the child reading, audio books, YouTube reading books, siblings reading to the other children (great way for one to work on reading aloud while the other works on listening skills). Some easy ways to get this time in are during mealtimes, rest time, bedtime while the child is awake – sleeping while audio books play doesn't count. Other ways are games, and don't think that games are just for elementary children. There are games for all ages and fields of learning. One field that has some great learning games is chemistry. Games are great for reviewing things that have been learned.

Another place to get hours is watching educational movies/TV. There are many fantastic educational videos on history and science. Your child may have something that they want to learn about, which gives a great reason to go explore your local library, museums, or visit with people who are in that field or have studied that specific topic.

## FHE Historical Records

Families for Home Education (FHE) was founded in 1983. In late 1984, with FHE's backing, a class action lawsuit was filed to declare Missouri's compulsory education statute void for "vagueness" and "overbreadth".

By Federal Court Order of July 5, 1985, Judge F. Nangle ruled that the portion of RSMo (1978) statute 167.031, which related to instruction at home, be and is void. The court limited its ruling only to the "vagueness" question. Since there was no alternative statutory provision for home education in Missouri, the Court transferred to the Legislature the responsibility of enacting a new statute by May 15, 1986, the final date of the 1986 Missouri Legislative Session.

In the end, the FHE proposed bill did not prevail. Instead, a much more contorted bill, Senate Bill 795, went down to the wire, and passed the legislature in the last three minutes of the last day of the 1986 session. FHE did not endorse this version of the bill, but agreed not to oppose the bill. In spite of its problems, however, this bill did give complete freedom to parents to educate their children at home within certain guidelines easily met by any conscientious home educator.

Thus, "Missouri's home educators learned for themselves the ancient lesson that freedom is never free. Our current freedom to educate our children at home is the result of many long hours of prayer, lobbying, negotiation, education, letter writing and watchdogging. In the end, and as a result of their tremendous display of unity, home schoolers secured for themselves what many have said is one of the best home education environments in the nation. It is a fact that many families have moved to Missouri because of this greater educational freedom.

There will always be those who would steal that hard won freedom if we do not remain vigilant and united. So, to you, in this day and in this hour, heed this sober warning — **Freedom is both dear and expensive. It must be fought for to be gained and vigorously defended once attained.** May God grant us the collective wisdom and strength of spirit to guard our freedom well." (*First Things First*, "Educational Freedom in Missouri", pp. 7-8)

After 40 years, Families for Home Education (FHE) continues to exist to recognize and protect the right of every parent in Missouri to educate their child at home. We seek no financial aid from any government entity, and we ask for no further restrictions on the current statute governing home education in Missouri.

Hunker down with some great literature books for family reading time and break out the hot chocolate, blankets, and warm cookies.

Set up some board game nights for lots of family time and some learning to go along with it. Reading and spelling skills, memorization, and following directions are all part of Language Arts. Basic math skills, counting dots on the dice, spatial recognition (puzzles), strategy/critical thinking (Chess, Risk, etc.) and game banker are all Math. **H**omeschool Day at the Capitol has always been a favorite for our family. What a great field trip day and all hours count towards Social Studies, core. Our FHE program starts at 12:15 in the beautiful Capitol Rotunda with music from one of our homeschool groups, Watson School of Music, in St James, MO. If you have not heard them before, you are in for a treat. Then the program will start at 12:30 and run until around 2:00. Our lobbyist will give a update on what is happening in Jefferson City in regards to bills that may affect our homeschool law. And we will have visits from legislators, most who were either homeschooled as children and/or are homeschooling their own children. They are in the trenches with you and know exactly what you are dealing with. Come hear the words of encouragement. We will also have a Q&A time towards the end if time allows.

However, that is not all that is in store for you that day. Set up a tour of the Capitol, but call early since these generally fill up quickly. <https://mostateparks.com/page/55179/capitol-tours>

Visit your legislators and let them know you are there for the day. They love to see families. Homeschoolers are also a valuable voting voice, so don't be afraid to let them know you are at the Capitol and introduce your family to them. Contact them at least 2 weeks ahead of time to get on their calendar. Maybe they can introduce your family on the floor chamber or arrange for you to go to the top of the dome. And there are 2 amazing museums on both sides of the Rotunda. Also, go to the Secretary of State's Office for a free copy of the Missouri Constitution. It's a great addition to your homeschool library and resources.

The Supreme Court Building is on High Street across from the Capitol. You can schedule a tour by calling 573-751-4144. Also, the State Highway Patrol Safety Education Center and Museum is on East Elm and tours can be scheduled there as well, but may require at least 10 in the group. Call 573-526-6149 to set up that tour. The Governor's Mansion also has tours that you can schedule. It's just a block or so down the street from the Capitol, a leisurely walk without having to find another parking place.



### **Traditional Home School**

During the 2023 legislative session the Missouri Senate Education Committee brought forward a new school designation, the FLEX School (Family Led Education eXperience). To be clear, FHE did not come up with the idea of two legislative categories of homeschool families.

What would the two school designations mean?

A “traditional” home school would continue on as it has by providing a private or religious based education. The record keeping requirements and hours will continue as they have since 1986. No changes. A traditional home school would not participate in the public school activities or the MO Scholars program. This category is where most home educating parents probably fall.

The FLEX school students will be those students participating in the public school activities and/or the MO Scholars program. They will also be required to keep the mandated homeschool records and hours.

For all practical purposes the home school and the FLEX school students will continue to interact in co-ops, home education activities, etc. just as they do now. The difference will be a legislative difference.

Every year is unique in leadership, members, issues, etc. This makes each session full of uncertainties. Therefore, we can never be certain about what comes through the legislative process. These separate categories (Traditional Home School and FLEX) as outlined in several current bills *might* help to protect a traditional home school from encroachment by the law makers. There are no guarantees in this process, but the distinctions now *could* help in the future.

So, if future legislatures seek to impose more restrictions on families participating in public school activities/classes or MO Scholars while agreeing to protect traditional home school families, their efforts could more easily be directed to the one (FLEX) while protecting traditional homeschool families from those same restrictions.

Since the two categories of homeschooling families present no harm, FHE does not oppose the concept.

The FLEX school along with the non-traditional student participation in public school activities is included in 3 bills this year: SB 819 sponsored by Senator Ben Brown, SB 902 sponsored by Senator Nick Schroer, and HB 1905 sponsored by Representative Josh Hurlbert.

### **Non-Academic Involvement in Public Schools – FHE’s policy**

When dealing with non-academic involvement with public schools such as sports competitions and extracurricular activities or clubs, FHE must consider all dynamics. The three primary issues to balance are:

- 1.) Home school students having the equal opportunity to play on teams in their school district, or participate in programs or clubs with or without competitions.
- 2.) Home School sports teams afforded equal and fair access to play against public and/or private school teams of similar size and matched according to the same guidelines as other brick and mortar school teams. (cont. on page 9)

3.) First and foremost, adequate safeguards that home school sports or extracurricular participation does not result in additional regulatory schemes over home education.

FHE has no specific policy or legislative agenda in this arena other than to guarantee that no proposed legislation is advanced without appropriate protections against regulations.

Current public school policies are highly discriminatory against home education students in middle and high school grades. Participation in sports programs or non-academic extracurricular clubs and activities require a combination enrollment (enrollment in a home school and in the public school) of at least two hours of public school classes, but the local school may require more hours. This allows public schools to collect extra funding for those students, but it also creates an unfair and oppressive restriction on home school students and families.

While FHE recognizes these complications as unjust and discriminatory, we will not support any changes to the law unless it is balanced and guarantees home school freedoms. FHE will not support changes that only benefit some home school families and pit those who participate on home school teams against those who wish to join public school teams. Most importantly, FHE will not support any legislation that places home education or families at regulatory risks. Public school teachers who give qualifying grades to students to play on teams are never challenged, thus home schoolteachers must be treated the same.

Therefore, FHE is neutral on the non-academic involvement in public schools portion of the bills.

There are numerous other bills we are reading and watching. Stand by, check our website for Capitol report updates, and be ready to write an email or make a call if needed.
