HB 1911 Update (this is NOT an alert at this time):



While FHE is neutral on the bill itself (lots of non-homeschool related parts), we are strongly opposed to homeschoolers being a part of any tax credit. One of the main reasons for opposition is that the bill gives the Department of Revenue and the Treasurer the authority to promulgate (create) the rules. Also, it is a refundable tax credit which means a taxpayer could receive more money refunded than their tax liability. FHE does not want this to lead to a back-ended way of registering a home school. FHE seeks no financial aid from any government entity, and we ask for no further restriction on the current statute governing home education (directly or indirectly).
