SB 1391, sponsored by Senator Tony Luetkemeyer - Bill Summary SB 1392, sponsored by Senator Curtis Trent - Bill Summary

SB 1391 and SB 1392 are identical bills to HB 2104 which is being heard in the House Special Committee of Education Reform on Monday in the House.

FHE is asking the Committee members to remove a home school from the MO Scholars program. We have seen in other states how a home school being included in these kinds of programs can lead bills being brought forward that would bring government control over all home schools. The expansion of the MO Scholars program is just a prerequisite to a full-blown government funded ESA (Empowerment Scholarship Accounts) or ESA type of tax-credit programs and creates the high probability of more regulation being proposed for all home schools.

Although legislators have brought these bills with good intentions, the MO Scholars program, ESA bills, and Tax Credit bills is a means by which all forms of education, private and home schools become government schools. Missouri already has school choice: public, private, charter, parochial, and home school.

What school choice really means is the government is paying for not only public and charter schools, but also for private and home schools. Where there is "free" money there is also a "poison pill" of accountability (restrictions and regulations).

Don't be fooled by the "It's your money" or the "Money following the child". Once you pay your taxes to the Missouri Revenue Department, the county collector, sales tax, etc. it is no longer "your money". It is government money and government money always leads to strings.

FHE is not trying to be an alarmist, but we are committed to protecting the inalienable right of the parents of Missouri to teach their own children without further state regulation and control. Missouri homeschoolers have worked hard to secure our homeschool freedoms and maintain our freedoms. Let's work together to continue to do so.

All of these bills in some way expand the MO Scholars program.

## **Background information**

FHE, while being neutral on parts of this program that do not effect homeschoolers, has opposed some of the egregious rules created by the Treasurer's Office, especially the rule to require everyone living in the home of a home school 18 years of age or older to submit to a background check. HB 2104 removes a parent from the background check, but it does not take the 18-year-old child still living at home, or possibly, grandma living with the family out of the requirement.

HB 2104 and HB 1738 changes the tax credit a taxpayer contributes to the scholarship fund from a non-refundable tax credit to a refundable tax credit. A refundable tax credit is when a taxpayer can receive more money from the state than their tax liability. At this point, direct government money becomes part of the MO Scholars program. And again, government money always requires more accountability.

The best thing would be to remove a home school from the MO Scholars program before there is any expansion of the program. In other states which have started with similar programs to the MO Scholars and then advanced to full government funded ESA (Empowerment Scholarship Account) programs have seen immediate bills filings to put more restrictions on all home schools. This is a dangerous road to travel. Don't "sell your home school freedom for the money carrot".
